

**April Boyd Tier Match Offer
Hosted at Rio LAS VEGAS
OFFICIAL RULES**

Promotional period begins at 12:01am on Thursday, April 2, 2026, will end 7:00 PM Thursday, April 30, 2026. All times referred to throughout these Official Rules are Pacific Time ("PT"). As used herein "Casino" or "Rio" refers to Dreamscape Flamingo Road Management, LLC. d/b/a Rio Las Vegas, located at 3700 W Flamingo Rd, Las Vegas, NV 89103. April Tier Match shall be referred to as the "Promotion" throughout these Official Rules.

GENERAL RULES:

1. To be eligible to enter this Promotion, participants ("Participants") must be:
 - a. eligible to participate.
 - b. at least 21 years of age or older with proof of age that Casino, acting in its sole and absolute discretion, deems appropriate.
 - c. a resident of the United States; and
